লখনউ, ১০ অগস্ট: বানচাল হয়ে গেল স্বাধীনতা দিবসে নাশকতার ছক। উত্তরপ্রদেশ থেকে গ্রেপ্তার এক আইসিস জঙ্গি। রাজ্যের আজমগড়ের আমিলো থেকে তাকে গ্রেপ্তার করে উত্তরপ্রদেশ এটিএস। জানা গিয়েছে, স্বাধীনতা দিবসে আইইডি বিস্ফোরণের মতলব আঁচছিল ওই যুবক। সাবান্ডিনিনের গ্রেপ্তারের পরে রীতিমতো ডিড জমে যায় তার বাড়ির সামনে। ইতিমধ্যেই সংবাদমাধ্যমের সঙ্গে কথা বলার সময় ধৃত সাবান্ডিনিন আজমির ভাই সেলিম জানিয়েছেন, তার ভাই কীভাবে আইসিসের সঙ্গে জড়িয়ে গেলেন, সে সম্পর্কে তাদের পরিবার কিছুই বুঝতে পারছে না। এ প্রসঙ্গে বলতে গিয়ে সেলিম জানিয়েছেন, ও কোথাও যেত না। ওর আচরণ থেকে কখনও কিছু বুঝতে পারিনি। বলা হচ্ছে ও আইসিসের সঙ্গে যুক্ত। এটা আমাদের ধারণারও বাইরে।



এটিএস যে তাদের বাড়িতে হানা দিতে পারে সে সম্পর্কে যে তাঁদের কোনও ধারণা ছিল না তাও জানিয়েছেন সেলিম। তার কথায়, একজন পুলিশকর্মী এসে আমাদের পরিবারের সদস্যদের নাম জানতে চান। তারপরই একে একে সাদা পোশাকের দশজন এটিএস কর্মী সেখানে হাজির হন। তারা সাবান্ডিনিনের হাত ধরে তাকে

ভিতরে নিয়ে যান। শুরু হয় তর্ক। জানা গিয়েছে, সাবান্ডিনিন আজমির ওরফে দিলওয়ার খান ওরফে বেরাম খাঁ ওরফে আজার 'অল ইন্ডিয়া মজলিস-ই-ইত্তেহাদুল মুসলিমিনে'র সদস্য ছিল। সে নিয়মিত সোশ্যাল মিডিয়ায় আইসিসের হয়ে প্রচার করত। হোয়াটসঅ্যাপের মাধ্যমে চরমপন্থী ইসলামিক আদর্শ প্রচার করত সে। সেই সঙ্গে জঙ্গি হওয়ার প্রলোভন দেখাত বিভিন্ন ব্যক্তিকে। ধৃত জঙ্গিকে এটিএসের সদর দপ্তরে নিয়ে এসে জিজ্ঞাসাবাদ করা হচ্ছে বলে জানা গিয়েছে। সেই সঙ্গে খতিয়ান দেখা হচ্ছে তার মোবাইলে ফোনটিও। সাবান্ডিনিন পুলিশকে জানিয়েছে, ২০১৮ সালে বিলাল নামে এক ব্যক্তির সঙ্গে তার পরিচয় হয় ফেসবুকে। তারপর সেই ইমেইলে জড়িয়ে পড়া জঙ্গি কার্যক্রমে। তাকে জেরা করে আরও তথ্য জানার চেষ্টা করছে পুলিশ।

নয়াদিল্লি, ১০ অগস্ট: সুপ্রিম কোর্টে বড়সড় স্বস্তি পেলেন বহিষ্কৃত বিজেপি নেত্রী নূপুর শর্মা। প্রাণশশংয়ের আশঙ্কায় নূপুরের বিরুদ্ধে হওয়া সবকটি মামলা একত্রিত করার নির্দেশ দিল শীর্ষ আদালত। সবকটি মামলা স্থানান্তরিত করা হবে দিল্লিতে। পয়গম্বর নিয়ে বিতর্কিত মন্তব্যের জেরে দেশজুড়ে নূপুরের বিরুদ্ধে ৯টি মামলা দায়ের হয়েছে। দিল্লি, মহারাষ্ট্র, তেলঙ্গানা, পশ্চিমবঙ্গ, কর্ণাটক, উত্তরপ্রদেশ, জম্মু-কাশ্মীর ও অসম পুলিশ বহিষ্কৃত বিজেপি নেত্রীর বিরুদ্ধে মামলা করেছেন। সমস্ত মামলায় গ্রেপ্তারের উপর স্থগিতদেশ্য দেয় সুপ্রিম কোর্টের দ্বারস্থ হন নূপুর। সেই সঙ্গে সবকটি মামলাকে একত্রিত করার দাবিও জানান নূপুর। বহিষ্কৃত বিজেপি নেত্রীর বক্তব্য ছিল, তাঁর জীবনের ঝুঁকি রয়েছে। তাই ভিন্ন রাজ্যে গিয়ে আইনি লড়াই করা তাঁর পক্ষে সম্ভব নয়। নূপুরের করা আবেদনের ভিত্তিতে এদিন শীর্ষ আদালতে জানিয়ে দিয়েছে, যে সব রাজ্যে মামলা হয়েছে, সেগুলি দিল্লিতে ট্রান্সফার করতে হবে। উল্লেখ্য, এদিন আদালতে স্বস্তি পেলেও এর আগে অন্য একটি মামলায় গত ১ জুলাই শীর্ষ আদালতে চরম



তিরস্কৃত হতে হয় নূপুরকে। শীর্ষ আদালতের পর্যবেক্ষণ ছিল, আপনার বোফাঁস মন্তব্যের জেরে আজ গোটা দেশে আন্দোলন জ্বলছে। বিজেপি নেত্রী হুমকি পাচ্ছেন জেনে বিচারপতিরা মন্তব্য করেন,
